GENERAL INFORMATION:

- All utilities must be on at the time of the inspection.
If the property does not pass the initial inspection, a check list of predications, listing the violations will be given to the property owner/manager/agent at the time of inspection.
When all predications have been corrected, a re-inspection must be scheduled; the fee for a re-inspection is included. Each subsequent inspection is \$40.00.
An inspection expires after 120 days and will require a new inspection.
The applicant and/or new occupants must not move into the premises until the Occupancy Permit has been issued.
A new inspection is required upon any change in occupancy.

NOTICE: This is a visual walk thru inspection only. No equipment or appliance is taken apart for inspection nor does the City of St. Ann warrant or guarantee any condition.
